**PREPARATION & COOKING SUGGESTIONS**



Oven: - Preheat oven to 400 degrees - Remove frozen product from case and place on tray, then heat in oven for 9 minutes - Roll in cinnamon sugar mixture  
Fryer: - Preheat fryer to 360 degrees - Remove frozen product from case and place in fryer for 60 seconds - Roll in cinnamon sugar mixture
